Programs & Services Committee

#### Governance Committee

Tom Little noted that a thorough review of the policy will be done, and a revised policy should be ready for the Governance Committee to review at their September meeting.

### Audit

Chair John McSoley recapped the Audit meeting record of January 25, 2021 and presented the annual NIST Self-Assessment report (previously submitted to the Board) concerning cyber and data security controls, directing Board members to previously distributed materials. The Board engaged in a discussion of the report during which Laurie Oliver responded to member questions. John also provided a summary on the Internal Audit & Risk Management Status Report and noted the Annual Federal Trade Commission Red Flags Policy Review and the Committee's action approving the updated Red Flags program documents.

## Finance Committee

Board Chair Dodie Mitchell asked Mike Stuart to review the January 25, 2021 meeting in the absence of Finance Committee Chair Beth Pierce. Mike relayed that the meeting focused on the FY21 financial statements, private loan volume, and the upcoming 2021-2022 private loan bond issuance.
