


**FORM OF DISTRIBUTION DATE INFORMATION FORM**

This Distribution Date Information Form (the "Information Form") is being provided by People's United Bank, N.A. as trustee (the "Trustee") pursuant to Section 4.21 of the Indenture of Trust, dated as of June 1, 2013 (the "Indenture"), between Vermont Student Assistance Corporation (the "Corporation") and the Trustee. All capitalized terms used in this Information Form and not otherwise defined shall have the same meanings as assigned to such terms in the Indenture.

The Corporation has provided a Distribution Date Certificate to the Trustee.
