

Loan Interest Rate & Fees

Your **interest rate** will be either

5.90% or 7.45%

After the rate is set, it will be fixed for the life of your loan.

Your Interest Rate (upon approval)

The interest rate you pay will be determined when you apply and will be based on which payment option you select and if you are approved for that option. If you choose to make payments of principal and interest when the loan is fully disbursed your rate will be fixed at 5.90%. If you choose to delay all payments for 12 months from the final disbursement date your rate will be fixed at 7.45%; this choice is subject to VSAC approval and the availability of funds. If approved, we will notify you of the rate you qualify for based on your payment option.

Your Interest Rate during the life of the loan

Your rate is fixed. This means that your rate will remain the same for the life of your loan. For more information on this rate, see the reference notes.

Your rate will never change during the life of your loan. The rate is determined by your repayment option and will remain constant.

Loan Fees

Origination Fee: The fees that we charge to make this loan range from 0% to 5% of the total loan amount. **Late Fee:** 6% of the amount of the late payment. **Returned Check Charge:** \$10.00.

Loan Cost Examples

The total amount you will pay for this loan will vary depending upon when you start to repay it. This example provides estimates based upon two (2) repayment options that may be available to you.

Repayment Option	Amount Provided (amount provided directly to you or your school)	Interest Rate (highest possible starting rate)	Loan Term (how long you have to pay off the loan)	Total Paid over the Loan Term (includes associated fees)
1. PRINCIPAL and INTEREST PAYMENT Pay both the principal and interest amounts.	\$10,000	5.90%	15 years starting <u>after</u> the final disbursement.	\$15,090.46
2. DELAYED PAYMENT Make no payments until 12 months from final disbursement date. Interest will accrue and be added to your loan principal.	\$10,000	7.45%	15 years starting <u>after</u> the delayed period.	\$17,871.52

About this example: A single disbursement loan is assumed. The **Delayed Payment option** assumes that repayment begins 12 months after the final disbursement. The **Principal and Interest Payment option** assumes that repayment begins at final disbursement. For loan amounts of less than \$10,000, repayment will last 10 years (120 months) once the initial principal payment is made. For loan amounts of \$10,000 or more, repayment will last 15 years (180 months) once the initial principal payment is made.

REFERENCE NOTES

Interest Rate

This loan has a fixed interest rate. Your rate is determined based on the repayment option you choose when you apply for the loan.

Eligibility Criteria

Borrower Must:

- Meet VSAC credit requirements.
- Be a U. S. citizen or an eligible non-citizen.
- Be a Parent of an eligible student who is a Vermont resident or attending an eligible Vermont institution.
- Not be in default on an education loan.

Student Must:

- Be a U. S. citizen or an eligible non-citizen.
- Be enrolled or re-enrolling at an eligible post-secondary institution on an at least a half time basis.
- Be eligible for federal student aid.
- Be a Vermont resident or attending an eligible Vermont institution.

Bankruptcy Limitations

If you file for bankruptcy you may still be required to pay back this loan.
