



# VSAC Scholarships Program Disbursement Requirements

**2025-2026 ACADEMIC YEAR**

VSAC's Enrollment Verification and Disbursement Policy, and special instructions for Scholarships and Forgivable Loan Programs and the federal GEAR-UP Program are included below.

## **ENROLLMENT VERIFICATION AND DISBURSEMENT POLICY:**

- \* Please notify us immediately if a student is not enrolled, changes programs, or withdraws from school (less than 6 weeks into an enrollment term).
- \* VSAC will verify enrollment and academic standing after each term starts.
- \* All scholarships and forgivable loans administered by VSAC are disbursed by term.

## **SCHOLARSHIP FORGIVABLE LOAN PROGRAMS:**

Under certain circumstances, these loans may be forgiven, but fundamentally the aid is a loan, not a grant or scholarship.

Please be aware of the following when posting these awards to a student's account:

- 1) UVMED, VNGTBP, VTTRADES-T awards cover tuition only and therefore should not be refunded to the student. If other grant or scholarship aid specifically covers tuition, the loan amount must be reduced by that amount, and funds must be returned to VSAC (lowering the loan amount).
- 2) VTDENTIST, VTDHYGIENE, VTNURSEFAC, VTPSYCHNP, and VTNURSE2 awards may cover tuition, fees, room, board, books, and supplies. These funds may be refunded to the student if their account is satisfied.

## **GEAR-UP and GEAR-UP-R:**

The US Department of Education has attached a regulation to this scholarship. They have stated that the award must be treated as a "last dollar" award. Regulations pertaining to this statement are as follows:

- 1) Cost of attendance. A GEAR UP scholarship, in combination with other student financial assistance awarded under any title IV HEA program and any other grant or scholarship assistance, may not exceed the student's cost of attendance.
- (2) Continuation scholarships. A State, or a Partnership that chooses to participate in the scholarship component in accordance with section 404E of the HEA in its GEAR UP project, must award continuation scholarships in successive award years to each student who received an initial scholarship and who continues to be eligible for a scholarship.
- (3) Order of Scholarships. (1) In general in awarding GEAR UP scholarships, a State or Partnership must ensure that, for each recipient of a scholarship under this part who is eligible for and receiving other postsecondary student financial assistance, a Federal Pell Grant, if applicable, be awarded first, any other public or private grants, scholarships, or tuition discounts be awarded second, a GEAR UP scholarship be awarded third, and then any other financial assistance, such as loans or work-study, be awarded.
